

CIT Serves As Sole Lead Arranger of \$46.5 Million Financing for Cypress Creek Renewables

Financing to support construction of nearly 30 megawatts of solar power generation in North Carolina

NEW YORK, Feb. 7, 2018 /PRNewswire/ -- [CIT Group Inc.](#) (NYSE: CIT), a leading provider of commercial lending and leasing services, today announced that its Commercial Finance division's Energy Finance business served as sole lead arranger and administrative agent for \$46.5 million in construction-only financing on behalf of Cypress Creek Renewables, a developer and owner of solar energy facilities nationwide. The financing will support construction of six utility-scale solar projects in North Carolina totaling 29.9 megawatts.

The projects covered by this financing range from 4.5 megawatts to 5.0 megawatts with 10- to 15-year purchase power agreements from utilities. Individual projects will be located in Randolph, Gaston, Alamance, Jones, Pamlico and Rowan counties in North Carolina.
